1. Information About Us

2. Cookies

2.1. In this Cookie Policy, "Cookie" means a small text file placed on your computer by this website when you visit certain parts of the website and/or when you use certain features of the website.

2.2. Some of the Cookies we use have been developed and deployed to facilitate our provision of the website. These are known as first-party Cookies. We also utilise third-party Cookies, which are built by third-party vendors and employed on our website and are explained further below.

2.3. There are two types of Cookies used on our website: (1) "session Cookies" and (2) "persistent Cookies." Session Cookies normally expire when you close your browser, while persistent Cookies remain on your device after you close your browser and can be used again the next time you access our website.

2.4. This website uses analytics services provided by Google. Website analytics refers to a set of tools used to collect and analyse usage statistics, enabling us to better understand how Users use the Website. You do not have to allow us to use these Cookies, as detailed below, however whilst our use of them does not pose any risk to your privacy or your safe use of the Website it does enable us to continually improve our products and services.

2.5. The analytics services used by this website use Cookies to gather the required information. A cookie alerting you to the fact that cookies are used by this website will be placed immediately when you decide to visit our website for the first time, and it will not be possible to obtain your prior consent. You may remove this cookie and prevent future use of it by following the steps set out above.

2.6. This website also uses other Cookies to ensure it functions properly for the benefit of its users.
